## **MINUTES**

### **Welcome & Introductions**

- 1. Introductions and welcome for guests and members
- 2. Yarmouth Community Garden Joy Ahrens
  - o YCG is now an official municipal program existing as a subcommittee of the PLC.
  - Since 2002 the garden has existed on municipal land and has been supported unofficially by YCS and Yarmouth Recycling Facility.
  - o YCG provides 180 rental plots to residents(\$30) and non-residents(\$35)
  - YCG Community plot provides tons of produce to Yarmouth and Falmouth food pantry's and do direct delivery of goods to homebound families
  - YCG funds their activities through plot rentals
  - o YCG offers a variety of fundraisers and youth programming throughout the garden season
  - Action Items
    - Install bike rack
    - Construct shelter for the porta-privy
    - Cut trees shading the western rental plots
      - Boundary location needs to be confirmed before hedgerow cutting.

### 5. Land Acquisition Subcommittee report

- o LAsC met to further refine property acquisition priority statement
- o LAsC invited Alex, YPD to comment on this statement
- o There is currently a \$123K line in the 2017 municipal budget directed toward land acquisition.
- o Proposal to reduce 2017 funding to zero dollars will be presented to YTC.

# 6. Riverboat Preserve (Barker Preserve expansion) - Alan Stearns

- o Riverboat is a 22 acre lot between the now State of Maine owned (fmly SL&A) RR and the Royal River. There is a separate lot separated by the RR with a current residential subdivision application before the YPB.
- Components of an open space acquisition (parking, trailhead access, etc) may be integrated into the design of the subD
- Open space acquisition will be a YTC process. Subdivision application is a YPB process
- o PLC is encouraged to take an advocacy role with citizen and municipal leadership to support open space planning, continued funding and acquisition.
- This project is identified as an acquisition priority based on historic guiding documents,
   Yarmouth Green Infrastructure Planning and by the LAsC GIS models
- o There is a larger conservation context this Riverboat project could be a component of.
- o RRCT at RRCT cost has commissioned an appraisal
- RRCT is eager to partner with the Town to acquire this land for conservation purposes and offer public access.
- o RRCT prefers the Town owns and manages this preserve (expansion) including parking/trailhead and trail development.
- o RRCT is looking for clear, strong (unanimous?) signals from PLC, YTC, YPB, Yarmouth executive and leadership that Yarmouth is a willing partner.
