### 1) Pratts Brook Park

Andy and Mary created and hung new directional signage for trails, junctions, & You Are Here maps -Future Signage at PBP

Comments and suggestions were:

- To create some type of template that stipulates details of each of the six different types of signs used in PBP
  - o Trail, Junction, Kiosk, YOU ARE HERE, etc.
- Discussion of whether or not to use animal logos
- Move trail name/signage down the trail by X feet (some set distance)
- There is currently a search for hand-made, wood signs that keep a natural state of the park/trails

#### -Management Plan

Document Review, Key Issues: Bikes (Tony), Hunting (Sharon), Special Events/Athletic Events (Sharon)

It is important to put bullet points together to summarize PBP Meeting #1 (2/24/2016)

- -Goal for 5/25/2016 meeting is to discuss Bikes, Hunting, Rec'l uses/Dogs
- -Have deed restrictions available to share/discuss

#### 2) Property adjacent to Frank Knight Forest

-Alan summarized RRCT's standpoint and expressed interest from RRCT board and potential contributors that would require FKF and adjacent property land be put into conservation easement, if purchased with their support/backing/fundraising/etc.

-Committee member comments included: what would happen if the land stayed undeveloped (with the current owner or a new owner); one member would love to see more mtn bike trails possibly created there; one guest relayed their interest in seeing those properties be placed in conservation easements to prevent any portion of it/them from becoming developed; one guests commented on the possibility of connecting FKF to Brookside, John Howland, and the Bluffs via this possible parcel.

-Alan again suggested that the PLC consider three things when determining whether or not the PLC is interested in supporting this property...or ANY property:

1.) Policy...; 2.) Priority...; and 3.) Passion. The PLC is reminded that money is limited, and that they will need to decide which properties (as they come up) have more "worth" to them and to begin advocating.

-David Craig suggested that he will request the Town Council to discuss which parcels are of more importance to them.

# 3) Planning Board relations

- -The PLC discussed the proposed and modified "mission" statement.
- -It is important to get this into the hands of the Planning Board to show that PLC is there to help and assist with upcoming developments and possible land use requests or acquisitions.

- 5) May 17<sup>th</sup> CPIC event...there is a Parks and Lands Committee table to gain supporters and to show off what has been completed in the last year.

-Beth has offered to donate the centerfold map of the Open Space Guide for the Celebrate Yarmouth night on 5/17/2016. This tool can be used in many ways and will help to generate conversation as to where people live and which properties they enjoy.

-There should be some sort of information gathering sheet available to collect interested parties for work days, public meetings, and other potential partnerships in the future. (PBP Mngmt plan, FKF advocacy, Camp SOCI advocacy, etc)
